Arts Commission 2026 Cultural Affairs and Special Events Strategic Priorities

Ann Sylvester Cultural Affairs and special events director gave a presentation on

the strategic goals fro 2026 of Ann's division. Ms. Sylvester talked about City Square and events coming from June through August, a lot of weekly and monthly programming. Red carpet Corridor from May 1st - 3rd, sounds of Route 66 on May 1st in the city square and surrounding businesses. Some things coming back this year are Star Wars Day and Kids Fest. Race Fan Rally is coming back. The Official City Square Ribbon Cutting will be June 26th and 27th and featuring music food and a drone show. She showed the final design for the Unity Dome by Sijia Chen.

Ms. Sylvester gave an update on Bicentennial Park and partnerships with local organizations and the programs they will be putting on.

She talked about starting a partnership to create a city wide calendar with the park district so there is one place to see city wide events.

Commissioner Volling asking about a pollinator garden.
Ms. Sylvester said to send her an email with a proposal.

Commissioner Romero said it was nice to see a plan. Good to see a road map and it will be good to see it in action.

Ms. Sylvester talked about starting up for the subcommittees for the arts commission to help spearhead those projects.
