He was able to have a conversation with Sydney Thompson about that and currently the city can do a page on the website for the arts commission, but not a social media page there isn't the staff to manage a social media presence at this time. Ann Sylvester Cultural Affairs and Special events Director talked about her conversations with Sydney on this topic and how the city doesn't currently have the staff to do more social media pages than they already have.

Discussion was had about what to include on the website and how they would like it set up, how it would be most effective in getting the information out.

There was a discussion with members and Ann about the Remembering the Fallen display and how many people attended and how it was advertised. There was talk about using the website for events like that to further advertise them to get the word out to people within the community.

Comprehensive Plan Update

Luke Gundersen gave the commissioners an update on the comprehensive plan. He spoke with Jayne Bernhard and she provided the comprehensive plan, and what is in there as far as arts and culture. Residents want more public art in was the feedback from the workshops we received. He continued to explain all of the different cultural and art related information that is in the current version of the comprehensive document, which is not a finalized document.

The commissioners asked a lot of questions about comprehensive plan and if the city is supportive in implementing this plan. They want a monthly update on that the city is doing everything in this plan as it stands. The commission wants to partner with the city to implement it.

The Arts commission would like to be put them on record that they like what is in the comprehensive plan in regards to art.

There was talk about a City Council liaison to the art's commission.

There was further discussion on the topic of the comprehensive plan.

Luke will provide a copy of the current comprehensive plan to the commissioners.

STAFF COMMENTS

Luke Gundersen gave some staff comments, he met with the grants coordinator Becky DeGroate, she did apply for the IACA grant that we received in the past and we would find out in August in September and it depends on how many people apply for it. Anywhere between \$2,500 and \$25,000 would be awarded. Becky will be attending our July meeting. She did mention a few other grants we can apply for.

Luke wants to set up two sub-committees to go over the public art ordinance and a community engagement committee for the set up of webpage. Luke discussed how the committees would work and timelines and implementation etc.

Commissioner Simpson asked about how many open spots on the commission there were, and a discussion about open spots on the commission was had, there are 4 open spots on the commission.

Commissioner Simpson had a discussion with the mayor about the wall on the side of the parking garage and was asking about updates to that. Ann Sylvester said they were still working on that.

Commissioner Romero asked about the IACA grant money was expended for this year. He wants to make sure we aren't just rushing to spend that money on August 1st. Luke is going to look into how much money is left from the grant.

A discussion about the poet laureate was had.
