Mr. Heitner read the staff report into the record. Planner Helen Miller noted the daycare special use permit was final at the Zoning Board of Appeals and would not need Council approval. Nathaniel Washburn with KGG, LLC appeared on behalf of the petition and mentioned concerns that came up at the Zoning Board of Appeals meeting, including traffic, pedestrian traffic, restaurant lot size, and stormwater management. In response to Commissioner Cox's question about development of Lots 1-3, Mr. Washburn noted Lot 1 would be developed, with basic site work completed on Lots 2 and 3. Two members of the public spoke in opposition to the petition. Mr. Washburn and Bill Caton addressed concerns about traffic, zoning, site location, and development need related to area growth.
