Ms. Bernhard provided an overview of the Programmatic Agreement between the City of Joliet, the Illinois State Historic Preservation Office, and the Advisory Council on Historic Preservation. Ms. Bernhard explained May was National Historic Preservation Month and

described four programs, including Places Matter Facebook Campaign, Annual Historic Preservation Awards Program, Historic Preservation Presentation to City Council, and “Stone and Steeples” Architectural and History Tour.

Ms. Bernhard provided an overview of the tour’s participating locations and schedule. A discussion was held about other possible churches participating in the tour.

Ms. Bernhard described Joliet Area African American Historic Context Study events that would take place in the summer at Bicentennial Park. In response to Ms. Stovall’s question, Ms. Bernhard confirmed the steering committee would perform outreach work for the events and highlighted Julie Alexander.

Ms. Merwin highlighted Mr. Adamowski’s quote in the National Trust for Historic Preservation’s magazine about the Joliet Steel Mill Main Office Building. Ms. Bernhard responded to Mr. Mikottis’s inquiry about the stones at that property.

Mr. Heinemann inquired about St. Pat’s name change. Ms. Merwin described the merging of Catholic Churches within the Diocese of Joliet.
