

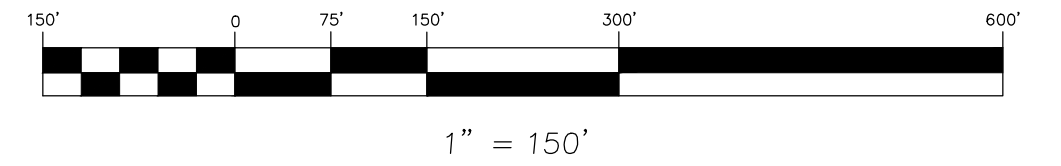
PLAT OF ZONING OF MCN Vista Ridge, Joliet, IL

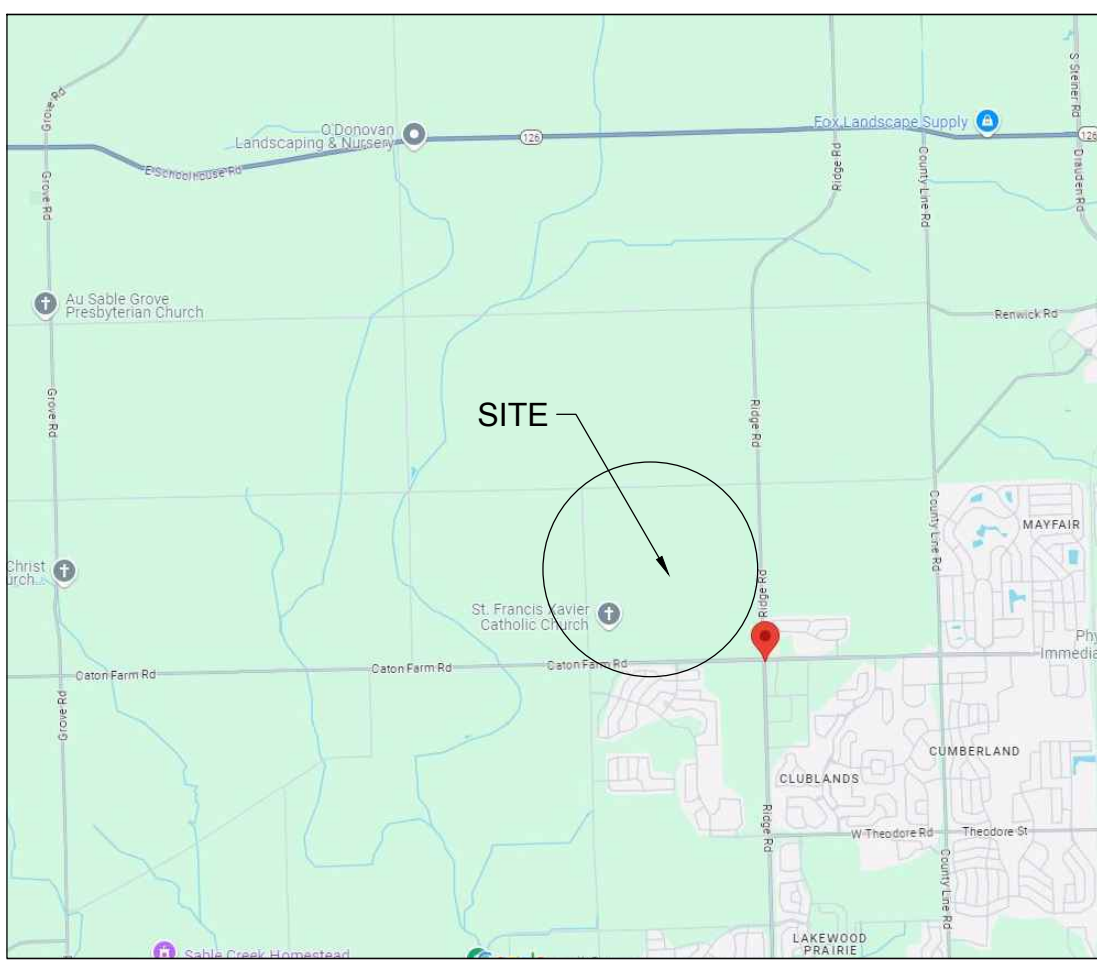

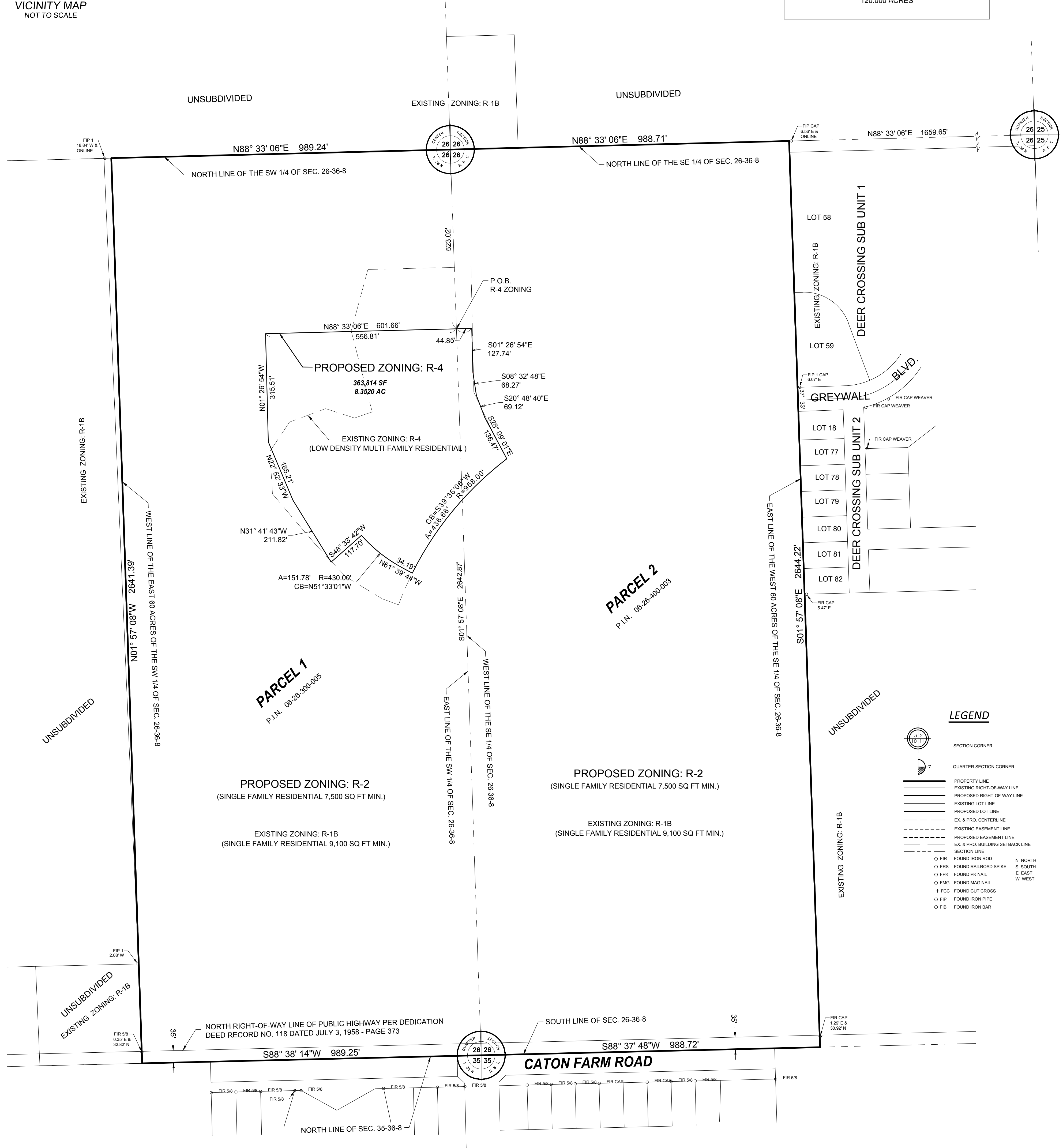
