Award of Contract to CDWG for the Renewal of Cradlepoint NetCloud Mobile Router Licensing in the Amount of \$44,278.00

**BACKGROUND:**

The City of Joliet currently uses Cradlepoint NetCloud Essentials for Mobile Routers to manage and secure our mobile networks. These routers provide strong wireless connections for vehicles, field workers, and remote sites, ensuring they stay connected.

NetCloud offers features like real-time network monitoring, advanced security, and easy integration with our current IT systems. This service is especially useful for our city's mobile units, such as emergency vehicles and remote field workers, providing them with reliable and secure internet access.

**CONCLUSION:**

To continue benefiting from the Cradlepoint NetCloud service, we need to renew our existing subscription licenses. This renewal will ensure our mobile units have reliable and secure connectivity, which is crucial for their operations.

To ensure competitive pricing, the renewal will be purchased using the Sourcewell-State of IL R-257160 contract.

**SUBJECT:**

Award of Contract to DTS for VUEWorks Asset Management Software Support and Hosting in the amount of \$70,000.00

**BACKGROUND:**

The city has been using VUEWorks for six years as its official asset management system. This comprehensive system tracks spatial and non-spatial assets, manages service requests, and handles work orders. Since its implementation, VUEWorks has experienced exponential growth, extending its usage to departments such as Public Utilities, Public Works, Information Technology, Community Development, and the Police Department. The city's popular citizen request portal and mobile app, CitizenVUE, are also supported by and integrated with VUEWorks. Over the past year, VUEWorks has continued to evolve, incorporating new features and improvements that enhance its functionality and user experience.

**CONCLUSION:**

Payment of the annual hosting, maintenance, and technical support fees is necessary to maintain use of this critical software system to manage the assets of the city and to respond to issues reported by residents. Renewing our VUEWorks subscription for 2025 will ensure uninterrupted service and support, allowing us to continue leveraging this essential tool for efficient asset management and responsive citizen service.

- (g) Purchases of professional services.

Sufficient funds exist utilizing the IT Contractual Services Budget (Org 04001000, object 524200, \$70,000.00).
