Luke Gundersen Special Events Coordinator, spoke about the proposal with Uxmar Torres for a continuation for another year of his contract. Luke talked about how we are compensating him currently for events which is per event currently instead of just an annual pay.

The commissioners asked questions about his pay and how moving forward for future poet laureate's we would compensate them, would it be the same. They had questions about how he would be compensated.

The commissioners wanted to see the contract that they would be agreeing to, but no contract had been created yet. There was discussion about not approving it because there was no money to pay him so he would be not paid for the year.

Luke explained where the no pay came from, in the proposal Uxmar submitted to the city himself.
