Staff Recommendations for CDBG Program Year 2026 Presented by Brigitte Roehr, CDBG Program Manager

Community Development Block Grant (CDBG) Program Manager Brigitte Roehr presented information on the 2026 application evaluation criteria, number of applications received, eligibility requirements, and staff recommendations for funding allocations.

Councilman Clement spoke regarding staff recommendations, earlier initiation of the application process next year, Will County's allocation of funds, and potential future funding opportunities for organizations.

Brigette Roehr discussed the evaluation criteria, its impact on small nonprofit organizations, ways to assist them moving forward, and Will County's allocation of funds. Community Development Director Dustin Anderson discussed staff recommendations and evaluation criteria.

Councilwoman Ibarra spoke regarding application scoring, increased access to funds for smaller nonprofits, and funding allocations for LEDA and African American Business. Dustin Anderson and Brigette Roehr addressed her comments.

Councilman Clement asked about the next CDBG deadline, and Brigette Roehr responded. Discussion followed regarding committee-level voting.

Brigette Roehr provided information about the Owner Occupied Rehab program, Miracle League, and options for changes to snow removal program eligibility requirements. Dustin Anderson provided background information regarding the snow removal program.

Councilwoman Ibarra inquired about the percentage of Sharefest clients served from the City of Joliet, and Brigette Roehr responded.
