Museum Update

The museum update was the last agenda item and began at approximately 8:40 a.m.

Councilwoman Ibarra thanked CEO of Joliet Area Historical Museum Greg Peerbolte for attending the meeting.

Mr. Peerbolte thanked the Committee Members, Facilities Management Director Blaine Kline, and Operating Engineer Brent Fraser for the air conditioning at the Joliet Area Historical Museum.

Mr. Peerbolte provided an extensive overview of the Old Joliet Prison's Blues Brothers Con 2024 and thanked the Committee members, Mr. Kline, Mr. Fraser, Joliet Police Department, and Joliet Roadways for their support of the event. Committee members congratulated Mr. Peerbolte.

Mr. Peerbolte asked if there were any questions about Blues Brothers Con or other museum properties. Councilman Cardenas highlighted the attendance, food vendor lines, food vendor options, and his overall experience at the Blues Brothers Con 2024. Mr. Peerbolte attributed

the event's smooth operations to Monica Bibian and his team. Councilwoman Reardon explained Mr. Peerbolte answered her question about food and highlighted her experience at last year's Blues Brothers Con. Councilwoman Ibarra inquired if merchandise was still available at the museum. Mr. Peerbolte responded yes.

At the request of Mr. Fraser, Mr. Peerbolte described upcoming events, including rooftop summer music series at the Joliet Area Historical Museum, Old Joliet Prison tours, Martin & Emma Planinsek Grocey and Meat Market Museum Grape Harvest Festival, and possible programs at the Joliet Railroad Museum.

BACKGROUND:

The Joliet Area Historical Museum located at 204 N Ottawa St. is operated by the museum staff but owned and maintained by The City of Joliet. The museum is home to exhibit areas, indoor and outdoor event space, Route 66 welcome center, and office space. The roof replacement consists of one main flat and three smaller flat areas. These roofs were last replaced over 20 years ago and frequent leaks in the main exhibit area have been an ongoing issue. The Roofing Envelope Replacement at the Joliet Area Historical Museum advertised in the Herald News on Friday, September 27, 2024.

CONCLUSION:

On Tuesday, October 15, 2024, at 10:00 a.m. three (3) sealed bids were opened and read in the City Hall Conference Room 2 for the Roofing Envelope Replacement at the Joliet Area Historical Museum. The bid summary is as follows:

BACKGROUND:

The Union Station Grand Ballroom is a historic site used for weddings, showers, and special events through a contract with Mistwood Golf Club since 2016. This historic space features a large ceiling space that hasn't been painted since the 1980's and has damage from smoke stains and water leaks over the years. The ceiling height requires lifts be used during this project. One coat of paint will be stain blocker and then two coats of flat paint. There is a limited timeframe to complete this work to not interfere with scheduled events. The work is expected to be completed in late December.

CONCLUSION:

The City of Joliet is seeking approval of labor and materials for the Union Station Grand Ballroom ceiling painting project. Staff contacted three vendors to obtain quotes for the scope of work. Three returned proposals. Staff is recommending the purchase be approved and awarded to Cosgrove Construction Inc. in the amount of \$67,625.00. Original projected estimates were \$150,000.00. The 2024 General Fund Budget provides funding for this project (Org 09015907, Obj 524300, \$67,625.00).

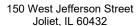

BACKGROUND:

Union Station uses two boilers for building heat. One of the two boilers has been decommissioned and since removed for nearly three years. The system is set to cycle boilers while in use and with only one boiler the stress put on the system will result in a shorter lifespan of the existing boiler. This heating system is critical for the numerous events held in the ballroom at Union Station.

CONCLUSION:

The City of Joliet is seeking approval of purchase for a Weil McLain Boiler to replace the decommissioned unit. Staff contacted three vendors to obtain quotes for the scope of work. Three returned proposals. Staff is recommending the purchase be approved and awarded to Anchor Mechanical Inc. in the amount of \$62,769.10. Original projected estimates were \$65,000.00. The 2024 Building & Grounds Budget provides funding for this replacement unit (Org 01015000, Obj 524300, \$62,769.10).

TERMS AND CONDITIONS

1. REMITTANCES - All invoices shall be due upon receipt and payable in United States currency, free of exchange, or any other charges, or as otherwise agreed upon and set forth in writing by Sendra Service Corporation (hereinafter called "Seller"). The Customer, if so requested, agrees to furnish Seller with all information necessary to make a proper credit appraisal, including financial statements, Tax ID number, bank account information, and credit references. A Customer's refusal to supply information may cause this proposal to be withdrawn. Terms of payment originally granted are

- subject to the approval of continued credit status. Prices are subject to correction for error.
- 2. PROPOSALS Proposals are based upon straight-time labor unless otherwise stated within the scope of the proposal. Any request by the Customer for overtime work shall be considered an extra to the proposal. This proposal expires 30 days after its date, subject to the provisions of the first sentence of the paragraph below entitled "Acceptance of Terms."
- 3. PROGRESS PAYMENTS Seller reserves the right to invoice Customer monthly as the work progresses, for all labor and materials delivered to the job site or to an off-site facility and for all work performed on-site or off-site. Engineering, drafting, equipment procurement, and other mobilization costs incurred prior to installation shall be included in Seller's initial invoice and be equal to a minimum of twenty five percent (25%) of the contract price. Invoices are due upon receipt by Customer. If the Customer becomes overdue in any payment, Seller shall be entitled to suspend work, shall be entitled to interest at the rate of 1½% per month or the maximum permitted by the State of Illinois, and to avail itself of any other legal remedies. Seller shall also be entitled to interest on all amounts retained by Customer from progress payments or otherwise. Customer agrees that Customer will pay Seller for all reasonable legal fees that are incurred by Seller in the collection of amounts due and payable hereunder.
- 4. CANCELLATION AND SUSPENSION Any contract resulting from this proposal is subject to cancellation or instructions to suspend work by the Customer only upon agreement to pay Seller an appropriate cancellation or adjustment charge.
- 5. TAXES The amount of any future sales, use, occupancy, excise, or other tax, federal, state, or local which Seller hereafter shall be obligated legally to pay, either on its own behalf or the Customer, with respect to the material covered by this proposal, shall be added to such prices and paid by the Customer.
- 6. LOSS, DAMAGE OR DELAY Seller shall not be liable for any loss, damage, or delay occasioned by any cause beyond Seller's control, including, but not limited to, governmental actions or orders, embargoes, strikes, differences with workmen, fires, floods, accidents, or transportation delays. IN NO EVENT SHALL SELLER BE LIABLE FOR ANY CONSEQUENTIAL OR SPECIAL DAMAGES TO CUSTOMER FOR ANY REASON.
- 7. WARRANTY Seller warrants that the equipment supplied and services furnished by it and covered by this proposal are free from defects in material and workmanship under normal use and service and, without charge, equipment found to be so defective in material or workmanship will be repaired or replaced, if written notice of failure is received by Seller within one (1) year after date of installation, provided said equipment has been operated in accordance with Seller's instructions and provided such defects are not due to abuse, fire or decomposition by chemical or galvanic action. THIS EXPRESS WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, GUARANTEES, OR REPRESENTATIONS, EXPRESS OR IMPLIED. THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE. Seller assumes no responsibility for repairs made on Seller's equipment unless done by Seller's authorized personnel, or by written authority from Seller. Seller makes no guarantee with respect to material not manufactured by it.
- 8. PURCHASER'S REMEDIES The Customer's remedies with respect to equipment found to be defective in material or workmanship shall be limited exclusively to the right of repair or replacement of such defective equipment. IN NO EVENT SHALL SELLER BE LIABLE FOR CLAIMS (BASED UPON BREACH OF IMPLIED WARRANTY) FOR ANY OTHER DAMAGES, WHETHER DIRECT, IMMEDIATE, FORESEEABLE, CONSEQUENTIAL, OR SPECIAL OR FOR ANY EXPENSES INCURRED BY REASON OF THE USE OR MISUSE OF EQUIPMENT WHICH DOES OR DOES NOT CONFORM TO THE TERMS AND CONDITIONS OF ANY CONTRACT RESULTING FROM THIS PROPOSAL.
- 9. REMEDIES OF SELLER Prior to the installation of the equipment and materials to be furnished and sold pursuant to this contract, title to said equipment and materials shall remain with the Seller, and, in the case of non-payment, Seller shall be entitled to any and all remedies of an unpaid seller under the Illinois Uniform Commercial Code, including the right of the seller to repossess said equipment and materials with or without legal process. After any or all of said equipment and materials have been installed pursuant to this contract, then as to that part of said equipment and materials which have been installed, and the labor and service related thereto, the Seller shall have the right to place a mechanic's lien against the premises where said equipment and material have been installed pursuant to the applicable statues and law relating to mechanic's liens for the furnishing of labor and materials.
- 10. GOVERNING LAW Any contract resulting from this proposal shall be governed by, construed, and enforced in accordance with the laws of the State of Illinois.
- 11. ACCEPTANCE OF TERMS This proposal shall become a binding contract between the Customer and Seller when accepted in writing by signature of the Customer. Such acceptance shall be with mutual understanding that the terms and conditions of this proposal are a part thereof with the same effect as though signed by both parties named herein and shall prevail over any inconsistent provision of said order.
