

AGREEMENT WITH JOLIET PARK DISTRICT FOR CAMERA PODS

This Agreement ("Agreement") is made and entered into as of _____, by and between the City of Joliet ("City") and Joliet Park District ("District").

Purpose:

The purpose of this Agreement is to establish the terms and conditions under which the City is authorized to install, operate, and maintain surveillance cameras and related equipment on property owned or controlled by the District, as mutually agreed upon by the parties. This Agreement also sets forth the City's obligation to indemnify and hold harmless the District from any claims, liabilities, or damages arising out of or related to the installation, operation, or maintenance of such equipment.

Installation and Maintenance:

The City shall be responsible for the installation, operation, and maintenance of the camera and related equipment. The City shall ensure that the installation and maintenance activities do not interfere with the District's operations.

Access:

The District grants the City access to the property for the purpose of installing, operating, and maintaining the camera and related equipment. The City shall coordinate with the District to schedule access to the property.

Incident Reporting and Video Preservation:

In the event an incident occurs at a park where cameras are installed under this Agreement, the District shall promptly report the incident to the City. Upon receiving such notification, the City shall preserve all relevant video footage for investigative purposes. The City shall document the incident and any video preserved or downloaded as evidence to ensure accountability, quality control, and oversight. Consistent with standard procedures, the City shall provide the District, as the victim or reporting party, with the applicable video footage related to the incident.

Indemnification:

The City agrees to indemnify and hold harmless the District, its officers, employees, and agents from any and all claims, liabilities, damages, and expenses arising out of or in connection with the installation, operation, and maintenance of the camera and related equipment at the District's property.

Liability:

The City shall be responsible for any damage to the District's property resulting from the installation, operation, and maintenance of the camera and related equipment.

Maintenance Responsibilities:

The City shall be responsible for the regular maintenance and upkeep of the camera and related equipment. The City shall promptly address any issues or malfunctions and ensure that the equipment is always in proper working order.

Term:

This Agreement shall remain in effect until terminated by either party upon 30 days written notice. Upon termination, the City shall remove the camera and related equipment within 30 days.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral, relating to the subject matter hereof.
