**Engagement Summary: Survey and Community Workshop
#1**

Lamar Johnson Collaborative consultants, Lesley Roth and Prayag Bagde, and MUSE consultant, Katrina Baylog, joined via Microsoft Teams. Ms. Baylog

presented highlights from the Joliet Comprehensive Plan Survey and Community Workshop #1 Engagement Summary document.

Discussion topics included table and appendix labeling, improving online engagement, the undecided location for the second workshop, prioritization of community input, and housing in east and southeast Joliet, focusing on diversification, affordability, multiuse development, and alignment with the Equitable Transit-Oriented Development (ETOD) Plan. Other items included private investment, city ordinances and zoning, declining school enrollment, birth rates, economic mobility, and document font and size.

Planning Director Jayne Bernhard explained that a vision, goals, and objectives document based on survey results, Existing Conditions Report (ECR) data, and consultant input was under review by City staff and would be the focus of the next meeting.

Ms. Bernhard explained that working groups were rescheduled, with two groups meeting in December and the remainder in January and provided an overview of the workshops. She asked the Committee to send invitations to workshop participants, encouraged attendance by all members regardless of chair/co-chair status, confirmed that key City staff would participate as appropriate, and noted a second set of working groups would follow the second community workshop. The Committee discussed working group size, RSVPs, space accommodations for larger groups, and translation tools to support participation. Ms. Roth emphasized that interest in a topic area was sufficient to participate.

STAFF REPORTS

Ms. Bernhard introduced Planner Francisco Jimenez, informed the Committee that the Comprehensive Plan Advisory Committee meetings would be televised, explained that City Council approved a memorandum of understanding with the Regional Transportation Authority for equitable transit-oriented development zoning, highlighted a virtual community meeting on November 13, 2025 for the I-80 Des Plaines River Bridge Community Plan, and noted that the second Comprehensive Plan community workshop was tentatively targeted for the second or fourth week of February 2026.

Mayor Terry D'Arcy highlighted the Joliet River Edge Redevelopment Zone and a meeting with regional mayors regarding a regional truck traffic plan. Councilman Cesar Cardenas emphasized marketing city plans to highlight ongoing efforts and how the plans align with one another, and Jen Howard suggested a one-page summary of city plans.

MEMBER COMMENTS

Boise Walker commented on the proposed data center and, in response to questions from Steve Randich and Nora Gruenberg, noted concerns about water use, electrical demand, and impacts on southeast Joliet residents. Mayor D'Arcy pointed out that questions remain about the proposal, and Community Development Director Dustin Anderson clarified that the item was tabled to November and would then be tabled indefinitely until outstanding questions were resolved. Juan Rico added that Joliet was well-positioned to support the infrastructure needs of data center development. Mayor D'Arcy emphasized making the best decision for the City and its residents, and Ms. Gruenberg raised the importance of diversifying the City's economic offerings.

Ms. Walker inquired whether recommendations would be made for the south and southeast sides, citing reduced industrial development in these areas. Mayor D'Arcy highlighted significant development opportunities in both areas. Jim Roelf emphasized the Comprehensive Plan would benefit the entire City. Wendell Martin encouraged shifting community meetings toward visioning.

Mayor D'Arcy emphasized the importance of the Urban3 analysis in understanding the City's current conditions. Mr. Anderson reported that the consultant is anticipated to provide presentations to the City Council and community toward the end of the first quarter of 2026.

Ms. Howard announced a Joliet Region Chamber of Commerce event at Hollywood Casino on November 19 featuring Kevin Cross and David Kaplan.
