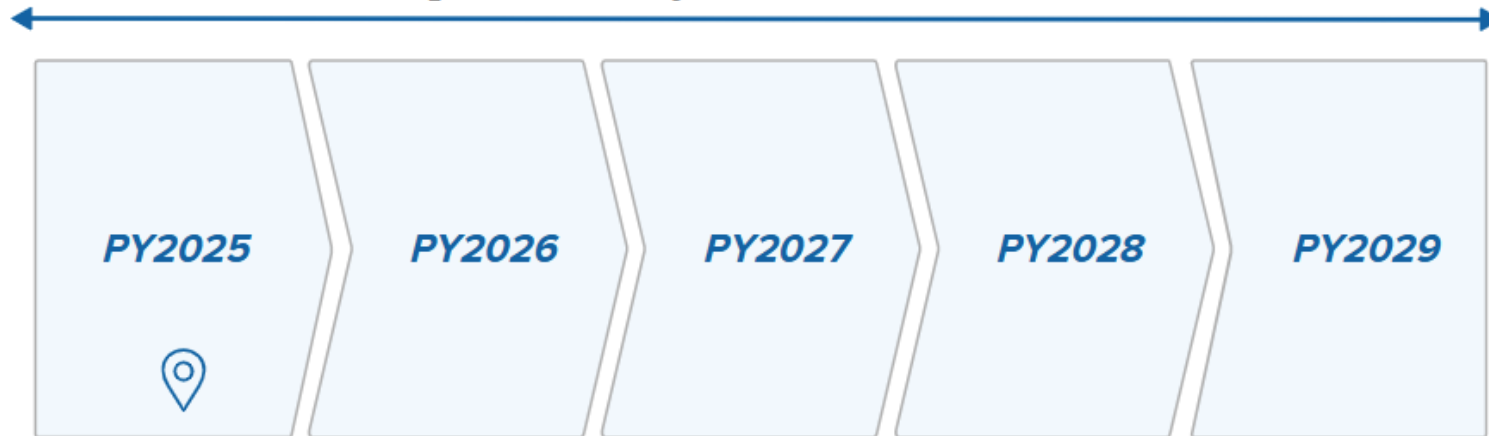


Overview

5 YEAR CONSOLIDATED PLAN:

-Prioritizes plan of action based on needs of the City through consultation of local Agencies, Neighborhood Committees, and Residents.

-Creates a map for each year of the Annual Action Plans.

- Summary of Goals and Objectives (Priority Needs)*
- Summary of Actions, Activities, and Resources (Funding)*

HUD uses each of these documents to hold grantees accountable to funding decisions

THE CONSULTATION PROCESS

- 46 Agencies/Organizations/Businesses consulted (up from 25)
- 13 Neighborhood Groups
- Resident Surveys completed in English and Spanish
& In person consults via Neighborhood meetings
 - Over 136 responses/attendees
- Responses based on:
 - Infrastructure Needs
 - Public Service Needs
 - Housing Market Analysis & Housing Cost Burdens
 - Non-Housing Community Development Assets

PY2025 - Application Cycle

ELIGIBLE ACTIVITIES

- All proposals must meet one National Objective
 - Benefit low / moderate income persons or area
 - Meet an urgent need
 - Aid in the prevention or eliminations of slum / blight
- and fit eligible activity category:
 - Public Service (15% Cap)
 - Public Facilities / Capital Improvements
 - Housing Rehabilitation
 - Economic Development
 - Administration (20% Cap)



PY2025 - Application Cycle

ADDITIONAL CONSIDERATIONS

- Duplicative applications from the County
- Clarification / outreach for follow up questions
- Reprogrammed funding from previous program years

APPLICATION CYCLE ACHIEVEMENTS

- Higher number of submitted applications
- Higher number of eligible applications
- Working with grassroots organizations towards governance, in preparation for future funding opportunities.
- Reprioritizing funds: 4 newly funded agencies/activities, Administration funds available for additional capacity building efforts.
