#### SUBJECT:

Approval of Professional Services Agreement for the Geotechnical Services for the Westside WWTP Expansion Project to SEECO Consultants Inc. in the Amount of \$51,965.00

#### **BACKGROUND:**

The design of the Westside Wastewater Treatment Plant (WWTP) Expansion Project is underway and geotechnical investigations are needed. The design of the proposed wastewater treatment plant expansion requires soil borings at 29 locations.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

In 2023 the Department of Public Utilities published a request for qualifications for engineering services, including geotechnical engineering, which generated a short list of the five most qualified geotechnical engineering firms. A Request for Proposal was sent to these five firms for the work needed for the Westside Wastewater Treatment Plant expansion project. On Friday, May 16, 2022, at 3:00 pm., two (2) proposals were received. The proposal summary is as follows:

The scope of work generally includes 29 borings, environmental testing, geotechnical engineering, and plan review in preparation for the design of the Westside WWTP Expansion Project. SEECO Consultants Inc has successfully completed projects of similar scope for the City.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases whose estimated cost is in excess of twenty-five thousand dollars (\$25,000.00) may be awarded without written specifications or bidding under certain circumstances. Two (2) of these circumstances apply:

- (f) Purchases when authorized by a concurring vote of two-thirds (2/3) of the Mayor and City Council.
- (g) Purchases of professional services.

Funds will be charged to the Westside Wastewater Treatment Plant Expansion Fund / Professional Services (Org. 53980000, Object 557200, \$51,965.00).



#### SUBJECT:

Award of Contract for the 2025 Traffic Signal Materials Purchase Order No. 3 to Traffic Control Corp in the Amount of \$56,156.00

#### **BACKGROUND:**

On Tuesday, May 20, 2025, an overhead ComEd electric wire came in contact with the traffic signal pole located on the southwest corner of the intersection of Jefferson Street and Stryker Avenue. This 12,000-volt wire damaged all of the traffic signal components at the intersection. The City of Joliet Electric Division made temporary repairs to make the traffic signals operational. Due to the extensive damage to the equipment, however, new materials are needed to replace the traffic signals components. Upon receipt of the materials, the City Electric Division will complete the repairs and will submit a claim to ComEd for reimbursement of the cost of materials and labor spent on this repair.

The Public Service Committee will review this matter.

#### CONCLUSION:

The City of Joliet has only one (1) approved manufacturer that supplies traffic signal materials. Traffic Control Corp is the sole source supplier of the materials. Traffic Control Corp provided a quote, in the amount of \$56,156.00, for the replacement of traffic signal materials requested by the City.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases whose estimated cost is in excess of \$25,000.00 may be awarded without written specifications or bidding under certain circumstances. Two (2) of these circumstances apply:

- (a) Purchases which may only be practicably made from a single source;
- (f) Purchases when authorized by a concurring vote of two-thirds (2/3) of the Mayor and City Council.

Sufficient funds exist utilizing the General Fund PW Electrical / Supplies - Equip Parts; Org 09028000, Object 536104, \$56,156.00.



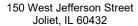

Approve Purchase of Replacement Sluice Gates for the Eastside Wastewater Treatment Plant from LAI & Associates Inc. in the Amount of \$41,700.00

#### **BACKGROUND:**

The Eastside Wastewater Treatment Plant utilizes three (3) Rodney Hunt sluice gates to isolate flow to final clarifiers No. 1-3. The gates originally installed in 1970 no longer seal and need to be replaced to ensure tank isolation.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

After inspecting the sluice gates, it was determined the sealing frames are worn and it would be most cost effective to replace the gates. LAI & Associates Inc., the local Rodney Hunt representative, was contacted to submit a price for replacement gates. The cost of the new sluice gates is \$41,700.00 and will carry a one-year warranty.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases whose estimated cost is in excess of twenty-five thousand dollars (\$25,000.00) may be awarded without written specifications or bidding under certain circumstances. Three (3) of these circumstances apply:

- a) Purchases which may only be practicably made from a single source;
- c) Purchases of equipment which, by reason of training of city personnel or an inventory of replacement parts maintained by the city, are compatible with the existing equipment owned by the city;
- f) Purchases when authorized by a concurring vote of two-thirds (2/3) of the Mayor and City Council.

Sufficient funds exist utilizing the Water & Sewer Improvement Fund / Eastside Wastewater Treatment Plant (Org 50180802, Object 557200, \$41,700.00).

#### RECOMMENDATION:

Based on the above, it is recommended that the Mayor and City Council approve the purchase of replacement sluice gates for the Eastside Wastewater Treatment Plant, in the amount of \$41,700.00, on behalf of LAI & Associates Inc.

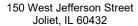

#### SUBJECT:

Approve the Payment of the 2025 Wastewater Discharge Permit Fees to the Illinois Environmental Protection Agency (IEPA) in the Amount of \$152,500.00

#### **BACKGROUND:**

Illinois law requires National Pollution Discharge Elimination System (NPDES) permit holders to pay an annual fee for the privilege of operating under the permit. The fee was first imposed in 2003 and has been payable on an annual basis since then.

At the present time, the City of Joliet has three (3) NPDES permits that are required for the discharge of wastewater and are subject to these fees.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

The fee for the NPDES permit for the Westside Wastewater Treatment Plant is \$50,000.00. The fee for the NPDES permit for the Eastside Wastewater Treatment Plant is \$72,500.00. This fee includes a fee of \$50,000.00 for the Eastside Wastewater Treatment Plant, a fee of \$20,000.00 for the Combined Sewer Overflow and a \$2,500.00 Sludge Generators fee. The \$2,500.00 fee for the sludge disposal program covers the disposal of sludge material from all three (3) plants. The fee for the Aux Sable Creek Basin Wastewater Plant is \$30,000.00. The total sum for all of the NPDES permit fees is \$152,500.00.

Funds will be charged to the Water / Sewer Operating Fund / Memberships and Dues ESTP (Org 50080802, Object 518001, \$72,500.00); WSTP (Org 50080803, Object 518001, \$50,000.00), Aux Sable (Org 50080804, Object 518001, \$30,000.00).

#### RECOMMENDATION:

Based on the above, it is recommended that the Mayor and City Council approve payment of the 2025 Wastewater Discharge Permit Fees, in the amount of \$152,500.00, on behalf of the Illinois Environmental Protection Agency.

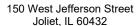

#### **BACKGROUND:**

On January 4, 2022, the Mayor and City Council approved a Professional Engineering Services contract for the Centralized Traffic Management System (CTMS) Improvement Project - Phase A to Iteris Inc. in an amount not to exceed \$364,397.00. Subsequently, the Mayor and City Council approved Amendment No. 1 in the amount of \$182,196.13.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

This original professional services contract included Phase I, Phase II, and Phase III engineering services to complete the initial project development, the preparation of contract documents for the implementation / construction, as well as construction oversight. Iteris Inc. has completed the initial project development that will be used with all future phases of the project. Iteris Inc. has also prepared the contract documents used to bid and award the construction contract for the CTMS Phase A and Phase B projects. Phases A and B include the first 75 traffic signals to be included as part of the City's Centralized Traffic Management System. The City will be expanding this professional engineering services contract to include the scope of work necessary to complete Phase C of the CTMS project.

The City has asked Iteris, Inc. to submit an amendment to the Phase I, Phase II, and Phase III Engineering Services with a Scope of Services and Cost Estimate to include Phase C of the CTMS project. The Scope of Services and Cost Estimate has been received and reviewed by the Department of Public Works.

The Services will be added to the original contract utilizing the time and material rates submitted at a total cost not to exceed \$149,919.73, resulting in a new contract cost of \$696,512.86.

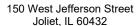

#### **BACKGROUND:**

On Tuesday, November 19, 2024, the Mayor and City Council awarded a contract to Great Lakes Water Resources Group, in the amount of \$184,226.00, for the rehabilitation of Well 28D.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

Great Lakes Water Resources Group completed the removal of the pumping equipment and took it to their shop for evaluation. Upon disassembly of the pump, it was determined it was able to be rebuilt and reused. The motor was sent in for evaluation and it was determined it could be refurbished and reused. Additional funds are required to complete work not anticipated in the original scope of work. These tasks include disassembling the pump bowl, reconditioning and reassembling the bowl for reuse, providing a downhole transducer to monitor water levels in real time, and shipment of the motor to and from Texas for service. Great Lakes Water Resources Group submitted a total cost of \$26,668.65 to complete the additional work. For comparison, the cost of a new motor and pump bowl would be approximately \$215,000.00.

Funds will be charged to the Water and Sewer Improvement Fund / Water Supply / Construction (Org 50180011, Object 557200, \$26,668.65, Project Code 24065).

#### **RECOMMENDATION:**

Based on the above, it is recommended that the Mayor and City Council approve Change Order No. 1, a net increase in the amount of \$26,668.65, for the Well 28D Rehabilitation Project to Great Lakes Water Resources Group.



#### **BACKGROUND:**

In June and July of 2023, Fleet Services requested permission to replace thirteen (13) large dump trucks for the Departments of Public Works and Public Utilities from Rush Truck Centers Inc. These items were included in the planned vehicle replacement program from the 2023 & 2024 budget years and were approved under Council Memos #263-23 & #359-23. These chassis are finally being built and will be received two (2) model years later than the initial purchase date. This delay was anticipated in the original requests. Body upfit of the chassis are being completed under separate contract. The body upfit company has met its promise to hold pricing flat during this timeline, so only the chassis have seen the price increase.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

The price difference per chassis from 2023 to 2025 is \$256,313.20 (approximately \$10K per unit, per year).



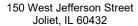

#### **BACKGROUND:**

The City of Joliet Administration proposes an ordinance amendment to Chapter 19, Article II of the City of Joliet Code of Ordinances. This amendment aims to establish limited two-hour free street parking in the downtown area in Zones A, B, and C. The purpose of this ordinance is to enhance street parking convenience for residents and visitors and support downtown businesses. The applicable zones are generally in downtown area and are depicted in the attached map in Exhibit A.

The proposed ordinance includes several key street parking restrictions:

- It shall be unlawful for any vehicle to be parked on Jefferson Street between Joliet Street and Mayor Art Schultz Drive, Cass Street between Joliet Street and Eastern Avenue, and Chicago Street between Washington Street and Jackson Street, in Zones A, B, and C between 3 A.M. and 5 A.M.
- A 2-hour street parking limit will be enforced in Zones A, B, and C between 7 A.M. and 7 P.M. Monday through Friday.
- Re-parking outside of the 2-hour limit within the same Zone during the hours of 7 A.M. and 7
   P.M. Monday through Friday will be prohibited.
- Parking restrictions in Zones A, B, and C shall be in effect from Monday through Friday, excluding holidays as defined in Section 2-7 of the City of Joliet Code of Ordinances.
- The effective date of the amendment to the ordinance will be September 1, 2025.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

This ordinance is designed to assist downtown businesses by attracting more customers and better serving the needs of the Joliet community. These changes are expected to enhance accessibility, convenience, and economic vitality in the downtown area, benefiting both residents and local businesses.

#### **RECOMMENDATION:**

Based on the above, it is recommended that the Mayor and City Council approve the attached ordinance amending the City's parking ordinance.

# ORDINANCE AMENDING CHAPTER 19, ARTICLE II OF THE CITY OF JOLIET CODE OF ORDINANCES TO ESTABLISH 2 HOUR FREE STREET PARKING, WEEKDAYS 7 A.M. – 7 P.M., IN ZONES A, B AND C IN THE DOWNTOWN AREA

**WHEREAS**, the City of Joliet seeks to provide free parking in designated areas to enhance accessibility and convenience for residents and visitors, thereby supporting downtown businesses by attracting more customers and fostering economic growth; and

**WHEREAS**, the City of Joliet desires to amend its parking regulations to reflect these changes; and

WHEREAS, the City of Joliet is a Home Rule Municipality, under and pursuant to §6 of Article VII of the Illinois Constitution, and has the authority to exercise any power and perform any function pertaining to its government and affairs, subject to the limitations set forth in the Constitution and laws of the State of Illinois, including, but not limited to, the power to regulate for the protection of the public health, safety, morals, and welfare; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF JOLIET, PURSUANT TO ITS HOME RULE AND STATUTORY AUTHORITY, AS FOLLOWS:

by the City Council of the City of Joliet, Illinois, that the following amendments be made to Chapter 19, Article II of the City of Joliet Code of Ordinances:

#### **SECTION 1:** Findings

The Mayor and City Council hereby find that the recitals contained in the remainder of this Ordinance are true, correct, and complete and are hereby incorporated into this Ordinance by reference.

**SECTION 2**: Amendment to Section 19-176(b)

#### [Amended language in bold]

That Chapter 19, Article II, Section 176(b) of the City of Joliet Code of Ordinances shall be amended by adding paragraphs (3) through (5) as follows:

- (3) It shall be unlawful for any vehicle to be parked on Jefferson Street between Joliet Street and Mayor Art Schultz Drive, Cass Street between Joliet Street and Eastern Avenue, and Chicago Street between Washington Street and Jackson Street, in Zones A, B, and C between 3 A.M. and 5 A.M.
- (4) It shall be unlawful for any vehicle to be parked for more than 2 hours in Zones A, B, and C between 7 A.M. and 7 P.M. from Monday through Friday and excluding holidays as defined in Section 2-7 of the City of Joliet Code of Ordinances
- (5) There shall be no re-parking outside of the 2-hour limit within the same Zone during the hours of 7 A.M. to 7 P.M.

**SECTION 3:** Repeal of Section 19-191

**SECTION 4:** Amendment to Section 19-193

#### [Amended language in bold]

That Chapter 19, Article II, Section 193 of the City of Joliet Code of Ordinances shall be amended to read as follows:

Sec. 19-193. Rates.

Unless otherwise specified in this article, Zone A, which is bounded by Cass Street to Washington Street and Joliet Street to the railroad tracks, Zone B, which is bounded by Crowley Avenue to Cass Street and Joliet Street to the railroad tracks, and Zone C, which is bound by Cass Street to Jefferson Street and Mayor Art Schultz Drive to Eastern Avenue, will have a street parking rate of zero dollars (\$0.00) per hour.



This Letter of Understanding (LOU) is made and entered into between the City of Joliet referred to as the LPA and the State of Illinois, acting by and through its Department of Transportation, hereinafter referred to as STATE and shall serve as a written record of the maintenance responsibilities for the ILL 53 and Emerald Drive project being administered by the City of Joliet.

Please indicate the LPA's concurrence by signing with original signature and return two (2) copies to our office for final processing.

The following items are added:

- All traffic control equipment to be used in the traffic signal work included herein must be approved by the STATE prior to its installation. The STATE must be notified a minimum of seven (7) working days prior to the final inspection. Final inspection of the signalized intersection will be made by a representative of the STATE, and, if satisfactory, authorization for turn on will be given.
- 2. Upon acceptance of the traffic signal by the STATE the financial responsibility for maintenance and electrical energy for the operation of the traffic signal at the intersection shall be proportioned as follows:

IL 53 at Emerald Dr	0% STATE	0% STATE

and become a part of the current Master Agreement executed between the City of Joliet and the STATE.

- 3. The actual maintenance of traffic signals at the above intersections will be performed by the STATE with its own forces or through ongoing contractual agreement.
- 4. The financial responsibility for the maintenance of the "Emergency Vehicle Preemption" equipment at the signalized intersection above shall be borne by the LPA.
- The STATE retains the right to control the sequence and timing of the traffic signals and interconnect.
- 6. Payment by the STATE of any or all of its share of maintenance is contingent upon the STATE receiving adequate funds in its annual appropriation.
- 7. It is mutually agreed, if, in the future, the STATE adopts a roadway or traffic signal improvement passing through the signalized intersection which requires modernization or reconstruction to said traffic signal then the LPA agrees to be financially responsible for the entire costs in accordance with Department policy to modernize or reconstruct said installation and will be responsible for all costs to relocate or reconstruct the emergency vehicle pre-emption equipment with the STATE's proposed improvement.

All costs associated with the installation, future maintenance, or replacement of non-standard Department equipment, finish or hardware shall be the sole responsibility of the LPA. This includes, but is not limited to, painting of the signal hardware, aesthetic poles, etc.

8. Upon final field inspection of the improvement, the LPA agreed to maintain, or cause to be maintained, those portions of the improvement which are not maintained by the STATE.

All provisions, conditions, restrictions and requirements of this agreement shall be binding upon and inure to the benefit of the successors, assigns, administrators, executors or heirs of the parties hereto.

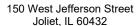

#### **BACKGROUND:**

At the June 2, 2020 Council Meeting, the Mayor and City Council approved Resolution #7537 appropriating Motor Fuel Tax funds for this project in the amount of \$420,000.00. Shortly thereafter, the Illinois Department of Transportation (IDOT) began disbursing the first allotments of Rebuild Illinois bond funds to be provided to local governments. The construction of Garnsey Avenue Bridge over the Spring Creek Improvement Project has been determined to be eligible to be funded by Rebuild Illinois bond funds. As standard MFT funds have already been allocated / expended for this project, this will essentially swap Rebuild funds for MFT funds, allowing the MFT funds to be allocated to a different project.

The Public Service Committee will review this matter.

#### **CONCLUSION:**

Funding for this project will come from Rebuild Illinois bond funds. The Illinois Department of Transportation requires the City to submit a resolution appropriating Rebuild Illinois funds and a request for authorization to expend these funds. Attached please find the standard IDOT forms attached for review and approval.

#### RECOMMENDATION:

Based on the above, it is recommended that the Mayor and City Council approve the attached resolution appropriating Rebuild Illinois bond funds, and the attached request for expenditure / authorization of Rebuild Illinois bond funds in the amount of \$420,000.00 for the construction of the Garnsey Avenue Bridge over Spring Creek Improvement Project - MFT Section No. 11-00443-00-BR.
