## ORDINANCE NO.

## AN ORDINANCE VACATING 5-FOOT LANDSCAPE EASEMENTS AND A 15-FOOT PUBLIC UTILITY AND DRAINAGE EASEMENT ON LOTS 3, 4, AND 5 IN CITY'S EDGE SUBDIVSION (2631 City's Edge Drive)

WHEREAS, the Mayor and City Council have determined that it is in the best interest of the City of Joliet to vacate and release the 5-foot landscape easements on the shared lot lines of Lots 3 and 4 and Lots 4 and 5 and the 15-foot public utility and drainage easement on the shared lot line of Lots 4 and 5 in City's Edge Subdivision identified and described in Exhibit "A" to allow the resubdivision of Lots 3, 4, and 5 of City's Edge Subdivision into two lots.

## NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF JOLIET, AS FOLLOWS:

**SECTION 1**: That the 5-foot landscape easements and the 15-foot public utility and drainage easement described in Exhibit "A" are hereby vacated and released.

<u>SECTION 2</u>: This Ordinance shall be considered severable, and the invalidity of any section, clause, paragraph, sentence, or provision of the Ordinance shall not affect the validity of any other portion of this Ordinance.

**SECTION 3:** This Ordinance shall be in effect upon its passage.
