Request: A series of Variations on signage for a future

museum

Purpose

The petitioner requests Variations on signage for a future museum, located at 9 W. Cass Street. The Zoning Board of Appeals makes the final decision for these variance requests, which include:

- A Variance to increase maximum sign height from 20' to 37'6" for a 24' tall by 9' wide sculpture;
- A Variance to allow an on-premise sign (sculpture) that exceeds 200 square feet in area; and
- A Variance to increase the total sign area for the property from 50 square feet to 860.6 square feet.

Site Specific Information

The subject property is approximately 5,280 square feet and is zoned B-2 (Central Business) District. The three-story white, terra cotta building faces south onto W. Cass Street. This circa 1930 building is a well-preserved example of a late Beaux Arts style / Sullivanesque style commercial building. The Joliet City Council designated this property, the "White Store" as a local historic landmark on August 4, 2020. At their July 27, 2022 meeting, the Joliet Historic Preservation Commission issued a Certificate of Appropriateness to allow the Museum to hang the proposed sculpture on the front façade.

Typical of commercial buildings of this era, the property has zero-foot front and side yard setbacks. There is an alley that runs along the western façade of the building as well as northern (rear) property line. There is currently a tree directly in front of the building and at the location of the proposed sculpture. The City Arborist has confirmed that the existing tree can be replaced with smaller ornamental tree.

The "White Store" (dry-goods) opened in 1930 at this location. By 1937, the White Store had outgrown the space at 9 W. Cass Street, and the business moved around the corner to the building at 235 North Chicago Street (which was the building most people

remember as the "White Store"). After the White Store relocated, the Goldblatt Brothers Department Store took over the building using it as an annex to their store across the street until the late 1950s. The building then changed hands several times. In 2019, the Illinois Rock & Roll Museum on Route 66 purchased the property and is currently renovating the building for a museum.

Surrounding Zoning, Land Use and Character

This building and property is in the heart of downtown Joliet. Central Business District (B-2) zoning surrounds the property on all four sides. The property is surrounded by a mix of entertainment, retail, office, and institutional uses.

Discussion:

The Illinois Rock & Roll Museum on Route 66 seeks three variations on signage for their future museum. The first two variance requests are related to the installation of a non-illuminated, 213.6 square foot, fiberglass guitar sculpture that is approximately 24' tall and 9' wide at the location where a previous large projecting sign had hung. The base of the sculpture will start at 13'6" off the ground and will rise to a final height of 37'6" off the ground. The City limits on-premise signs to a maximum of 200 square feet and limits sign placement to 20' in height in the B-2 (Central Business District). Therefore, the petitioner requests approval of these two variances. Specifications and narrative on the proposed sculpture can be found as an attachment.

The third variance request is to increase the total amount of signage for the property. Single-tenant properties in the B-2 (Central Business District) are limited to 50 square feet in signage. The Museum proposes 860.6 square feet of signage for the property, including:

- 213.6 square foot non-illuminated fiberglass guitar sculpture
- 642 square feet of non-illuminated window lettering and graphics on first floor "storefront" windows
- 5 square feet of non-illuminated awning lettering and graphics

The Museum contends that the window graphics will keep damaging UV rays off the future exhibits as well as hide the museum contents for security. Some of the window graphics have been installed. The attached photos depict the existing and proposed location of the window graphics.

ZONING BOARD OF APPEALS

CRITERIA FOR SIGN VARIATIONS

Section 47-17.21(3)(bb) of the Zoning Ordinance states:

Any sign which is not specifically permitted in any zoning district shall require the granting of a variation, obtained from the Zoning Board of Appeals. This includes signs that have flashing or pulsating illumination, animation, rotation, or overall dimensions which exceed the maximum dimensions permitted in any district.

Variation Criteria: A variation may be granted by the Zoning Board of Appeals based on all of the following criteria:

	Does the evidence presented sustain this criteria?	Comments
(a) That strict enforcement of the ordinance would cause undue hardship to the property owner due to circumstances unique to the individual property in question.		
(b) That the proposed use would not be detrimental to the use, orderly development and enjoyment of other property in the immediate vicinity for the purposes permitted under the zoning ordinance, nor substantially diminish the property value within the neighborhood.		
(c) That ownership or lease of the property in question can be demonstrated.		
(d) That approval of the variation would not be contrary to the objective of improving the overall appearance of the City.

1. How do the applicable zoning regulations prevent the property in question from yielding a reasonable return?

The museum is requesting permit to place a sculpture as depicted in the attached photo (exhibit A) to the front of the building at 9 W. Cass St. It is similar in size as to what was previously on the front of the building as shown in (exhibit B). The sign itself will be an attraction to the Museum and to Downtown Joliet.

Window graphics cover clear windows to keep damaging UV rays off of exhibits while hiding the contents of the building for security reasons.

2. What unique circumstances exist which mandate a variance?
The Museum received a grant to install a sculpture that will rise 24 feet from above the first floor
of the building. The sign will help to attract tourism to the area through the Illinois Rock & Roll
Museum located at this site.

No Changes to the terra cotta façade are needed:

The Illinois Rock & Roll Museum Building is located at 9 W. Cass Street in downtown Joliet. This building was formerly the White Store and GoldBlatts. Below is a photo of a sign that was attached to the building were the proposed sculpture will be. There are steel I-beams that protrude from the building and the terra cotta was placed around the I-beams when the previous signs were hung. With that said, the terra cotta will remain untouched and unaltered. New galvanized steel I-beams will be welded to extend the support as it had been previously. The beams along with the existing hang points above are more than sufficient to hold the full weight of the sculpture and resilient enough to with stand high winds and storms.

Creation and installation:

There are two components to the building of this sculpture. First is the creation of the sculpture and the second is the installation.










SCULPTURE ASSEMBLY




ARMATURE TO U-BRACKET TO WALL


