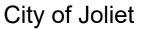

BACKGROUND:

The Mayor and City Council previously approved the 2021 City of Joliet Budget. The 2021 Roadways Resurfacing Contract B is a part of this budget. The project was advertised on Thursday, August 12, 2021. The Public Service Committee will review this matter.

CONCLUSION:

On August 30, 2021, at 9:50 A.M., two (2) sealed bids were received for the 2021 Roadways Resurfacing Contract B. The bid summary is as follows:

<u>CONTRACTOR</u>	BID AMOUNT
P. T. Ferro Construction Company	\$2,413,582.69
Austin Tyler Construction	\$2,580,782.45
Engineer's Estimate *:	\$2,604,722.00

The low bid by P. T. Ferro Construction Company, in the amount of \$2,413,582.69, is 7.3% under the engineer's estimate. The Engineer's Estimate as read at bid opening was corrected. Sufficient funds exist utilizing Motor Fuel Tax Funds / Infrastructure (Org 20090270, Object: 557200, \$2,413,582.69).

RECOMMENDATION:

Based on the above, it is recommended that the Mayor and City Council award the 2021 Roadways Resurfacing Contract B, in the amount of \$2,413,582.69, on behalf of P. T. Ferro Construction Co.

BACKGROUND:

The City of Joliet has been approved to utilize Rebuild Illinois Bond Funds received from the State for the design and construction of Chicago Street from Jefferson Street to Webster Street. Items not eligible for Rebuild Illinois funding, including the decorative streetscape design elements, will be paid for with local development funds.

The primary objective of the Phase I Engineering Services is to develop a preliminary improvement plan that builds off the 2018 Chicago Street Corridor Plan and provides the desired level of traffic safety and operation, minimizes the impacts to adjacent properties, and fulfills all of the requirements for processing and funding of this project by the City of Joliet and Illinois Department of Transportation. The Public Service Committee will review this matter.

CONCLUSION:

The City of Joliet must follow the procedures in the Illinois Department of Transportation Bureau of Local Roads and Streets Manual for retaining a professional consultant to complete the engineering services. The City of Joliet invited five (5) consultants to submit their qualifications to complete the Phase I engineering services. Interviews were conducted with three (3) consultants and it was determined that Civiltech Engineering, Inc. was best qualified to complete the requested services. This sewer rehabilitation project was publicly advertised for bid in the Labor Record on Thursday, August 12, 2021. The Public Service Committee will review this matter.

On Friday, August 27, 2021, at 9:00 a.m., five (5) sealed bids were received for the 2021 Sanitary Sewer Point Repair Project - Various Locations. The bid summary is as follows:

Award of Contract for the Emergency Repairs to the Rock 3 Well to Water Well Solutions Illinois LLC in the amount of \$257,500.00

BACKGROUND:

On August 6, 2021, the Rock 3 well failed unexpectedly. The Rock 3 well, located in the eastern well field, provides water to the downtown low zone as well as the east high zone. Currently two other wells in the eastern well field are out of service due to planned maintenance and emergency failure. To ensure the City maintains adequate water production in the eastern pressure zones, Water Well Solutions Illinois LLC, the local Centrilift pump and motor manufacturer representative, was called on an emergency basis to remove the pumping equipment for evaluation. The Public Service Committee will review this matter.

CONCLUSION:

Water Well Solutions Illinois LLC removed the pumping equipment and determined the reason for failure was the motor and motor seal failed. They also determined that ten (10) sections of pipe needed to be cut and rethreaded for reinstallation. The cost for the needed repairs to return the well to service is \$257,500.00. This includes a new motor, seal, pump, removal, reinstallation, as well as shipping the failed motor to Centrilift for a rebuild evaluation. If it is determined the motor can be rebuilt and made available as a spare, a separate contract would be brought to Council for approval of this work.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases over \$25,000.00 may be awarded without written specifications or bidding under certain circumstances. Two (2) of these circumstances apply:

The City of Joliet, Public Utilities Department, utilizes five (5) SCADA (Supervisory Control and Data Acquisition) systems comprised of multiple control systems to operate and monitor critical City facilities which include the Eastside Wastewater Plant, Westside Wastewater Plant, Aux Sable Wastewater Plant, the City-wide Water System, and the City-wide Sanitary Lift Stations.

Each system is comprised of multiple pieces of hardware and a complex code that controls multiple systems and pieces of equipment. When the City upgraded these systems they standardized on hardware and the System Integrator, Wunderlich Malec. The Public Service Committee will review this matter.

CONCLUSION:

Wunderlich Malec has provided a proposal in an amount not to exceed \$40,000.00 used in a time and material format as needed for approximately October 2021 through September 2022. The Administration has been satisfied with the timeliness and quality of their work. The service under this Contract requires detailed knowledge of the City's facilities and SCADA systems. Also included with this Agreement is a one (1) hour response time for emergency services on a 24 hour basis.

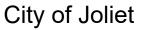

SUBJECT: Report on Utilities' Maintenance Activities

The following maintenance activities have been conducted since last reported at the August 3, 2021 Public Service Meeting:

<u>Hydrant Repairs</u>: Thirty-three hydrants have been repaired. There are currently 54 out of service hydrants (0.6% of 8351) and 19 hydrants that are operational but need repairs (0.2% of 8351).

Valve Repairs: Three valves have been reset or repaired.

<u>Water Main Breaks</u>: Eleven water main breaks have been repaired. For 2021, there have been a total of 152 water main breaks. We had 103 water main breaks in 2020, 199 in 2019, and 161 in 2018 for the same time period.

There were no new contracted services.
