#### SUBJECT:

Request to Approve Changes to the Bureau of Justice Assistance FY 20 Coronavirus Emergency Supplemental Funding Program

#### **BACKGROUND:**

The Bureau of Justice Assistance, Office of Justice Programs, from the U.S. Department of Justice, has made available funds for the specific purposes of preventing, preparing for, and responding to the coronavirus. Based on population and Uniform Crime Reporting numbers, the City of Joliet was eligible to apply for, and was awarded, a total of \$119,390.

In the interest of efficiency and effectiveness, our department decided to adjust purchases approved under this grant program. A Grant Award Modification was approved by the Bureau of Justice Assistance to forego the purchase of ultraviolet disinfection systems in favor of two distinct projects.

The first project involves the purchase of a Cordico wellness app dedicated to and designed for law enforcement personnel. This app provides confidential resources for all law enforcement personnel to ensure their emotional health. A one-year subscription for all law enforcement personnel, retirees and family members that wish to access it, will cost \$40,000.

The second project involves the purchase of individual air purifiers for most areas where our employees work and interact. Only two companies in the country have developed individual systems FDA-approved to kill the COVID-19 virus instead of trapping it in a filter. This ensures our employee's safety. After viewing the filter changing requirements, we have identified those produced by Molekule as most beneficial. Based on the square footage of all offices and shared spaces, a total of 73 individual air purifiers as well as the necessary filters for 3.5 years are expected to cost \$79,390

### **CONCLUSION:**

The Joliet Police Department has received approval from the Bureau of Justice Assistance to reallocate the funds awarded under the FY 20 Coronavirus Emergency Supplemental Funding Program. The two specific purchases of the Cordico mental health app and Molekule air purifiers will ensure our employees' mental and physical health as we continue to navigate the COVID-19 pandemic.

#### RECOMMENDATION:

Based on the above, it is recommended that the Mayor and City Council approve the request to approve changes to the Bureau of Justice Assistance FY 20 Coronavirus Emergency Supplemental

Funding Program. It is also recommended that the Police Department be allowed to purchase a one-year access to the Cordico mental health app and a total of 73 individual Molekule air purifier systems and additional filters for individual offices and common areas for both stations. Funds can be drawn down in advance of this purchase through the Grants Management System.

### **Crossing Guard Summary (08/2021)**

### **Positions and Staffing:**

- There are currently 42 crossing shifts (each morning and afternoon) that need to be filled and 1 administrative position for a total of 43
- There are 7 opportunities to combine 2 shifts due to location and timing, thus allowing for a reduction of 7 positions overall or 35 total that must be filled each day
- The Department needs 35 Guards to fill each days shift fully. However, due to the ongoing Covid pandemic and manpower shortages, the Department currently has 21 Guards

### **Compensation:**

#### Current:

- Tier 1: Guards make \$48.17/day (grandfathered employees)
- Tier 2: Guards make \$32.00/day (less than one year seniority)

\$36.00/day (1 year anniversary) \$40.00/day (2-year anniversary)

- Double Shift Bonus: Guards make an extra \$6/day if they cover a second AM or PM crossing OR an extra \$12/day if they cover both AM & PM of the second crossing
- If a Guard works only an AM or PM shift of their primary crossing, they receive ½ days' pay

### Proposed:

- Tier 1: Guards make \$48.17/day (grandfathered employees)
- Tier 2: Guards make \$32.00/day (less than one year seniority)

\$36.00/day (1 year anniversary) \$40.00/day (2-year anniversary)

• Double Shift Bonus: Guards make an extra ½ days' pay if they cover a second AM or PM crossing OR an extra full days' pay if they cover both AM &PM of the second crossing.

(The Department is currently 14 Guards short resulting in 10 crossing guard locations going unfilled on a daily basis. We are proposing the increase in the double shift bonus because of the ongoing pandemic/manpower shortage, Guards are not willing to fill the open crossing locations and take on the added work for \$6 or \$12 per day. Some of these spots require the Guards to travel across town multiple times and their complaint is the pay barely covers the cost of fuel).

Purchase of one (1) Ford Explorer for the Police Department Traffic Unit

### **BACKGROUND:**

The police department traffic unit enforces truck traffic ordinances that affect our citizens and roadways daily. The 2021 budget originally had \$62,416 allocated for the purchase of truck scales for weighing purposes. Recently, many different locations with certified scales have become available to our officers for weighing tractors and trailers for little or no cost to the City of Joliet. Transporting and utilizing mobile scales is very labor intensive and time consuming, compared to the options that our officers now have. It has been determined that a better use of these funds would be to purchase an additional truck enforcement vehicle to safeguard our citizens and roadways.

### **CONCLUSION:**

A 2021 police package Ford Explorer was located at a dealer in Wilmington, IL for \$45,656.92. No other dealers have any police package Ford Explorers in stock. No orders for these vehicles are currently being accepted as production plants are still shut down. This vehicle will need to be further upfitted by CAMZ Communications with additional lighting (\$1,755.80), Element Graphics for marking (\$750.00), and the City of Joliet IT department for Communications Gear (\$5,000.00).

Sufficient funds are available for this \$53,162.72 purchase in the 2021 Capital Improvements Budget Organization Code 30060020 Object Code 557400. The finance director has been consulted on this purchase and has given approval to utilize the funds for an alternate purpose.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases over \$25,000.00 may be awarded without written specifications or bidding under certain circumstances. One of these circumstances applies:

1. (f) Purchases when authorized by a vote of two-thirds (2/3) of all members of the city council then holding office.
