BACKGROUND:

The Black Road Lift Station utilizes a four (4) ton overhead bridge crane to perform pump maintenance. Originally installed in 2012 the existing crane was submerged in water due to a catastrophic failure of the station in late 2020. City Staff called the original installer to evaluate the crane for repairs. The original installer recommended the crane be replaced since the cost to repair the crane exceeded the cost for replacement. A set of specifications was prepared by City Staff for the replacement.

The Black Road Lift Station Bridge Crane Replacement was advertised in the Labor Record on Thursday, July 22, 2021. The Public Service Committee will review this matter.

CONCLUSION:

On Monday, August 30, 2021, at 10:30 a.m., two (2) sealed bids were opened and read for the Black Road Lift Station Bridge Crane Replacement. The bid summary is as follows:

The Eastside Wastewater Treatment Plant utilizes two (2) grit chambers to remove inorganic solids from the incoming wastewater. The south chamber originally installed in 2001 utilizes a wooden shed to house the pumping equipment. Over the past 20 years the wooden shed has deteriorated and needs to be replaced to ensure the pumping equipment is protected from the elements. A set of plans and specifications were prepared for the replacement building. The proposed building will be constructed of fiberglass to match the north grit chamber.

The Eastside Wastewater Treatment Plant South Grit Chamber Building Replacement was advertised in the Labor Record on Thursday, July 22, 2021. The Public Service Committee will review this matter.

On August 13, 2021, Well 5D failed unexpectedly. Well 5D, located in the eastern well field, provides water to the downtown low zone as well as the Southeast high zone. Currently two other wells in the eastern well field are out of service due to planned maintenance and emergency failure. To ensure the City maintains adequate water production in the eastern pressure zones, Layne Christensen Inc., the local Byron Jackson pump and motor manufacture representative, was called on an emergency basis to remove the pumping equipment for evaluation. The Public Service Committee will review this matter.

CONCLUSION:

Layne Christensen Inc. removed the pumping equipment and determined the reason for failure was a worn pump due to iron build up. They also found multiple pipe joints were leaking. The cost for the needed repairs to return the well to service is \$117,933.00. The cost includes rebuilding the pump back to factory specifications, servicing the motor, and rehabilitating multiple pieces of pipe including installing new couplings and check valves.

Section 2-438 of the City of Joliet Code of Ordinances states that purchases over \$25,000.00 may be awarded without written specifications or bidding under certain circumstances. Two (2) of these circumstances apply:

- (e) Purchases where an emergency immediately affects the public health, safety, or welfare, if authorized by the City Manager or his designee.
- (f) Purchases when authorized by a concurring vote of two-thirds (2/3) of the Mayor and City Council.

Sufficient funds exist utilizing the Water & Sewer Fund Operating Fund / Wells (Org 50180011, Object 557200, \$117,933.00).

RECOMMENDATION:

Based on the above, the Administration recommends that the Mayor and City Council approve payment, in the amount of \$117,933.00, on behalf of Layne Christensen Inc.

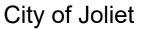

SUBJECT:

Purchase Water Metering Equipment from Core & Main in the amount of \$747,520.00

BACKGROUND:

The City of Joliet Department of Public Utilities maintains a citywide Automatic Meter Reading (AMR) system to read consumption data from approximately 49,000 meters on a monthly basis. This system consists of three (3) main components, including water meters, SmartPoint radios, and the radio-read / tower infrastructure. The City's Meter Shop, with contracted backup as needed, performs repairs and replacements to water meters, SmartPoint radios, and associated equipment.

Due to the worldwide microchip supply chain problems, the City's water meter manufacturer has recently experienced significant manufacturing delays. To minimize future risk to the City, the Public Utilities Department is recommending purchase at this time of sufficient metering equipment quantities to meet our needs for approximately one (1) year. The Public Service Committee will review this matter.

CONCLUSION:

Sensus meters have been the City standard since 1987, and Core & Main is the sole authorized area distributor of Sensus equipment. To meet the City's needs for approximately one (1) year, the following meters and related parts will be ordered at this time. It is estimated that half of the meters will be delivered and funded in 2021. The remaining half will be delivered early in 2022 and charged to the FY2022 budget.
