The Governor's Office and the Illinois Department of Public Health activated the mitigation plan for Region 7, effective August 26, 2020. Region 7 includes Will and Kankakee counties. The new Region 7 mitigation plan limits in-person meetings to 25 people or 25% of overall room capacity (whichever is less). Council Chambers allows for 13 members of the public while adhering to social distancing guidelines.

During meetings, any member of the public physically present in the Council Chambers in excess of the limit will be asked to wait in another room with live feed to the meeting until the Citizens To Be Heard on Agenda Items section or Public Comments section of the meeting has commenced. Speakers will be rotated into Council Chambers to allow everyone an opportunity to speak.

Pursuant to the Illinois Department of Commerce & Economic Opportunity's Guidelines, it is recommended that any individual appearing in-person wear a face-covering to cover their nose and mouth.

He would like to have a conversation with the City Council, Mayor and City Manager in order to get a consolidated plan.

Councilwoman Gavin asked if Mr. Mays had a proposal to submit. Mr. Mays responded he would like to see the City's plan first before submitting his proposal.

Mr. Jerry Hervey inquired about the cannabis tax dollars and asked if it has been spent. Councilwoman Gavin responded. Mr. Hervey had suggestions on where the money should be spent.

Ms. Suzanna Ibara asked if there is a projected amount for the money. Councilwoman Gavin said she would have to check with the Finance Department.

Ms. Regina Bew Jones inquired about the money and asked if it could be used for certain programs. Ms. Jones stated concerns about the area surrounding Englewood and feels the cannabis dollars can be used to build the area up.
